On August 15, 2013 Troy Alan Miller registered with the Ravalli County Sheriff's Office as required by Montana State Law. Miller, the individual who appears on this notification, has been convicted of sex offenses that require registration. The District Court Judge of Lincoln County has designated Miller as a Level 3 offender and sexually violent offender.

MILLER IS NOT WANTED BY THE POLICE AT THIS TIME.

THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

The Ravalli County Sheriff's Office does not have the legal authority to direct where a sex offender may or may not live unless court ordered restrictions exist.

Further, such abuse could potentially end law enforcement's ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power through secrecy.
